It is submitted that [Approved EOI](#) was floated on CPP Portal vide [Tender Id No 2025 ESIC 889264 1](#) on 10.12.2025. The last date of submission of bids and date of opening of EOI was scheduled for 31/01/2025 & 01/01/2026 at 11:30 am respectively.

The Committee, as constituted vide Note# 94 dated 22.08.2025, opened the Expression of Interest (EOI) for appointment of a Consultant on 01.01.2026 at 11:30 am ([Committee Report dated 01.01.2026 Linked](#)).

During the opening of the EOI, it was noted that [only two bidders](#), namely M/s CRISIL Limited and M/s B2K Analytics Pvt. Ltd formerly M/s Brickworks Analytics Pvt Ltd, participated in the process. The EOI documents received were as under:

- a. EOI document submitted by [M/s CRISIL Limited](#)
- b. EOI document by [M/s B2K Analytics \(P\) Ltd/ Brickworks Analytics \(P\) Ltd](#)

The constituted committee in their bid evaluation report dated 06/01/2026 submitted that [Rule 184 of the General Financial Rules \(GFR\), 2017](#) stipulates that the number of shortlisted consultants shall not be less than three. However, since only two EOIs were received, the requirement prescribed under Rule 184 of the GFR, 2017 has not been met ([Committee Report linked](#))

To ensure competitive pricing and wider participation, the Committee recommended for retendering, subject to the approval of the Competent Authority ([Committee Report linked](#)).

The Committee Report has been physically signed by three members. The remaining one member, has conveyed his [consent through email](#).

In view of the receipt of only two EOI's and as per the recommendations of the constituted Committee, it is proposed for inviting a fresh EOI through retendering.

- 3) The SEBI listed bidders were also contacted telephonically and informed about floating of EOI for Consultant Appointment with a request for their participation in the bids.
- 4) The information related to floating of EOI was also published in national newspapers namely [Amar Ujala](#), [Dainik Jagran](#),

[Hindustan Times](#), [Indian Express](#) on 13.12.2025 for wider publicity among the prospective bidders.
